#### **SUPERINTENDENT REPORTS**

Enrollment – September 2012

Supt. LaMarre reported that the district has grown about 5% (31 students) since September 2011 and there is one additional teacher on staff.

Mental Health AB3632/Special Education Funding Update on Reimbursement The one student who was attending a non-public school in the past is officially moved to high school. There are currently no mental health funded students in the district.

**Charter Conversion Update** 

The CDS code has been granted for Gravenstein First and the business office is working on separating the accounting system by school.
