## I. <u>CALL TO ORDER - ROLL CALL</u>

Meeting called to order at 5:31p.m. Members present/absent: Members Arif Virji (parent and a member of parent-teacher org), Amy Gloeckner (parent and a member of parent-teacher org), Eric Martin (parent of child in District) and Steve Schwartz (parent of child in District) were present. Members Jack Atkins (Bona-fide Taxpayers Association) and Gary Bachelor (Community at Large) were absent.

### II. INFORMATIONAL ITEMS

Superintendent LaMarre welcomed the group and explained that she had asked Arif Virji to chair the first meeting until the group was able to select a chair person, vice chair and a secretary. She also explained during the meeting:

- the role of the committee,
- that length of terms of the committee members is two years,
- meetings must be conducted following the Brown Act,
- and that by law the committee must meet once a year but can meet more often.

Members present signed the Ethics Policy Statement.

A. Fiscal Review / Measure M

District Business Manager Catrina Howatt reviewed the financial statements from the issuance of the Bond in May 2013 to date.

B. 2012-13 Measure M General Obligation Bond, Election of 2012 Financial Audit

Mrs. Howatt briefly explained to the group that the audits are done by the same CPA firm the Board hires to perform the District's annual audit. She showed how the financial report distributed above ties to the audited financial statement. If the committee has any questions about the audits, please get them to Superintendent LaMarre and she will make sure the questions are answered.

- *C.* 2012-13 Measure M General Obligation Bond, Election of 2012 Performance Audit The report was distributed to the committee.
- D. Presentation by District Architect Doug Hilberman with AXIA Architects on the Hillcrest Bond Project
   The District Architect Doug Hilberman introduced the Hillcrest project, shared a cost estimate
   (\$2,618,582) and the project timeline (est. Jan 2015).

  Mr. Hilberman also answered a few questions about the Master Plan, voters approving six million for
   bonding, issuing three million in bonds, coordinating projects to try to use State funding along with Bond
   funding and the timing of the next phase.
- E. Chair of Committee

Arif Virji nominated Steve Schwartz as Chair, Eric Martin as Vice Chair and Amy Gloeckner as Secretary. Steve Schwartz seconded. 4-0 yes.
