Supt. LaMarre reported that this plan is no longer required by the state. No action taken.

G. Establish Facilities Sub-Committee Pres. Horn suggested that he, Mem. Beck, and Superintendent LaMarre become a sub-committee to research and discuss facilities projects in the district, in order to report back to the board.

H. Consideration of computers for grades 3-8

Supt. LaMarre recommended that the district purchase laptops for all homeroom classrooms in grades 3-8. She also recommended any class that has a laptop cart in it, have an alarm. A discussion is had about the possibility of each room having an alarm keypad. Supt. LaMarre reported that acquiring Chromebooks for grades 3-4, and 7-8 would cost \$130,000-\$150,000. This would be in addition to the Chromebooks already planned for grades 5-6. A discussion was had about the wireless capability at each campus. Gravenstein has upgraded wireless equipment and can accommodate a class of Chromebooks connecting wirelessly.

Pres. Horn moved to table this to the May meeting, Wickland seconded, 4-0 yes.
